

# AIME LLM COMPETITION

## OFFICIAL RULES / TERMS OF USE

**NO PURCHASE NECESSARY TO ENTER OR WIN.**

A purchase or payment will not increase your chances of winning. Void where prohibited.

### 1) Sponsor

This promotion (“Promotion”) is sponsored by Ainvest Fintech Inc. (“Sponsor”)

### 2) Overview

Participants may guess which LLM managed account will perform best during the Competition Period. After the Competition Period ends and results are finalized, Sponsor will conduct a random drawing from all eligible entrants who correctly predicted the top performing model to select one (1) winner of the Prize described below. Promotion details (entry tasks, phases, and prize) are summarized below.

### 3) Promotion Period & Phases

All times are **Eastern Time (ET)**.

- **Betting Period:** From October 30<sup>th</sup> 2025 through November 15, 2025. Entrants may review real time model performance and place or change their prediction at any time before the Betting Period ends.  
  
**Competition Period:** November 17, 2025– December 19, 2025 Model data is reset at the start, live standings may be displayed.
- **Freeze & Results:** Model data freezes on December 19, 2025. A Performance Summary will be published, and on December 23, 2025, Ainvest will randomly select the winner from eligible entrants who predicted the winning model.

If Ainvest adjusts dates and or times due to operational needs or events beyond its control, Ainvest will post notice on the landing page.

## 4) Eligibility

Open to natural persons who, as of the date of entry, are:

(a) 18 years of age or older (or the age of majority in their jurisdiction, if higher); and (b) legal residents of the 50 U.S. states and any additional countries/regions Sponsor lists on the landing page). Employees, officers, and directors of Sponsor and its affiliates, and members of their immediate households, are not eligible. Void where restricted or prohibited.

## 5) How to Enter

During the Betting Period, complete all of the following tasks (collectively, “Entry Tasks”):

1. Register for an Ainvest account;
2. Follow Sponsor’s official account on X (Twitter); and
3. Place a prediction (“bet”) choosing the LLM managed account you believe will finish #1 during the Competition Period.

Only one prediction per person will count at the close of the Betting Period (the last valid prediction you set before the deadline). Completing the Entry Tasks does not require a purchase or trading activity.

**Limit:** One (1) total entry per person/email, regardless of method. Multiple entries or automated entries are void.

## 6) Winner Selection

After the freeze, Sponsor will identify the top performing LLM managed account under the performance methodology used internally for the standings.

- **Drawing:** On or about December 23, 2025, Sponsor will conduct a random drawing from among all eligible entrants who correctly predicted the winning model.
- **Odds:** Odds depend on the number of eligible correct predictions received.
- **Potential Winner Notification:** Sponsor will attempt to notify via the email on file within five (5) business days of the drawing.
- **Liability/Publicity Release** (where lawful), tax forms, and any other documents requested by Sponsor within seven (7) days of notice. Failure to timely respond or return documents, or if a notice is returned as undeliverable, may result in disqualification and selection of an alternate.

## 7) Prize

- **One (1) Prize:** US \$1,000 (paid via a method designated by Sponsor) and one (1) Apple MacBook Air (model and configuration in Sponsor's sole discretion).
